Most importantly, the citizens of this nation are seeing themselves as the custodians of their environment and they have become aware of how their actions can affect the health and welfare of their communities.

Assuring compliance with the environmental laws of our nation is one of EPA's primary commitments. In carrying out this responsibility, we use many different approaches. One of them is to seek help from citizens by asking them to provide us with information about potentially harmful environmental activities in their communities and workplaces. This has led to state and federal enforcement cases and ultimately served environmental protection well.

We invite you to help us protect our nation's environment by identifying and reporting environmental violations.

Signs of possible environmental violations that you might observe:

Signs of Possible Violations:

- ◆ Strong, offensive, or unusual chemical odors
- ◆ Large numbers of dead animals, including birds or fish
- ◆ Pipes or valves that bypass waste water treatment systems
- ◆ Tank trucks discharging into drains, manholes or surface waters
- ◆ Oily slicks on bodies of water
- ◆ Corroded, leaking waste containers
- ◆ Barrels dumped at odd hours in out-of-the-way places
