A RESOLUTION OF THE FREDERICKSBURG AREA METROPOLITAN PLANNING ORGANIZATION ALLOCATING FISCAL YEARS 2017-2022 CMAQ AND RSTP FUNDS

WHEREAS, FAMPO receives a yearly allocation of Federal Regional Surface Transportation Program (RSTP) and Congestion Mitigation and Air Quality (CMAQ) funding with a state match; and

WHEREAS, it was requested by VDOT that all the MPOs in the Commonwealth that receive CMAQ and RSTP funding allocate their funds for the next six years so that the project allocations can be shown in the FY2017-2022 Six-Year Improvement Program (SYIP); and

WHEREAS, FAMPO staff working with the FAMPO Technical Committee (FTC) and consulting the Fredericksburg VDOT and the Fredericksburg Commonwealth Transportation Board (CTB) member have been reviewing candidate projects and developing a strategy for allocation the funds over the next six years; and

WHEREAS, FAMPO staff received updated cost estimates from VDOT for six operation studies in the Fredericksburg area; and

WHEREAS, the attached documentation identifies the recommended allocations of CMAQ and RSTP for Fiscal Years 2017 through 2022 with the updated cost estimates for the six operational studies received from VDOT in June 2016.

NOW THEREFORE BE IT RESOLVED BY THE FREDERICKSBURG AREA METROPOLITAN PLANNING ORGANIZATION THAT IT HAS HEREBY ALLOCATED FISCAL YEARS 2017 THROUGH 2022 CMAQ AND RSTP FUNDS PER THE ATTACHED TABLE.
